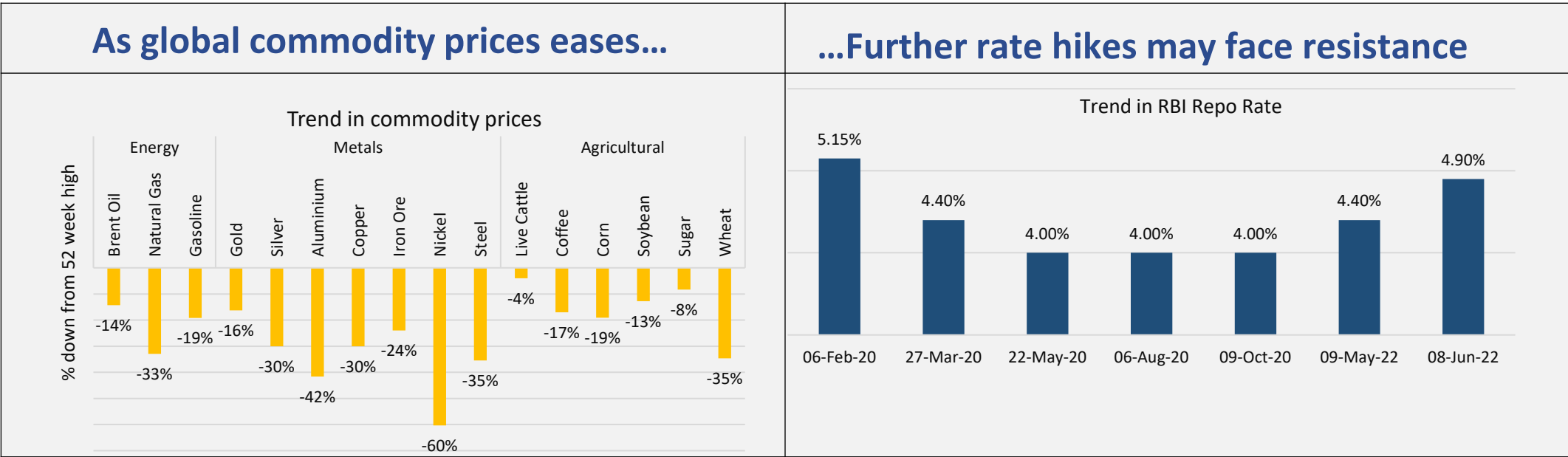

Past rate hikes coupled with easing commodity prices may bring inflation under control, making RBI relook at further rate hike actions

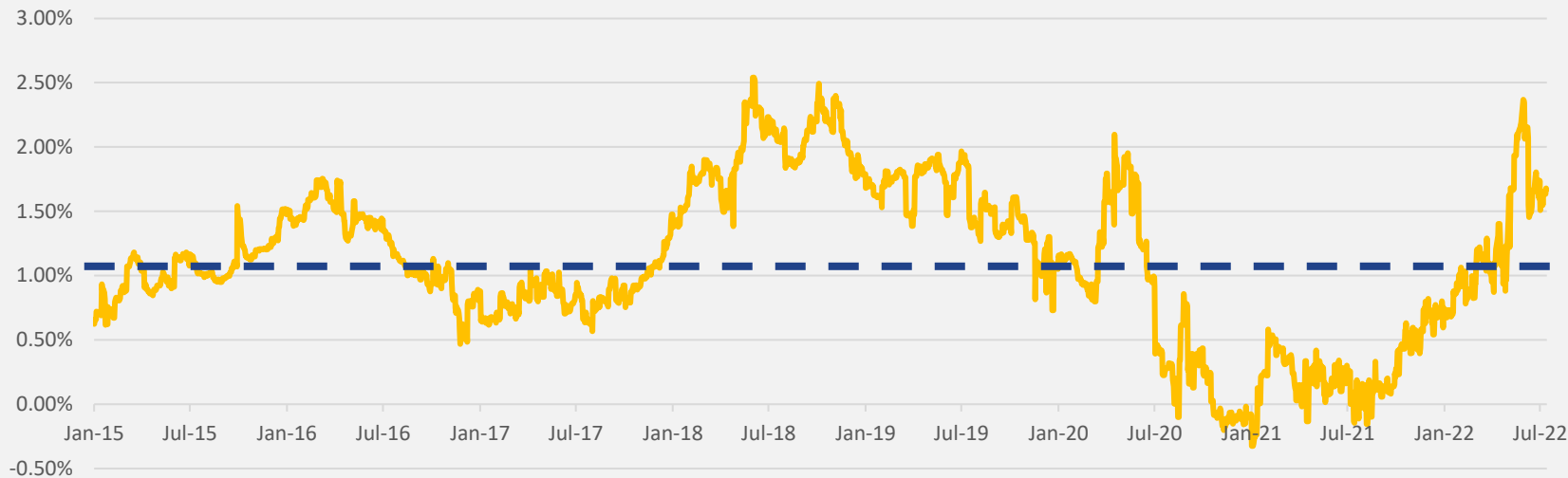
- The fund proposes to invest in money market securities having maturing upto 1 year

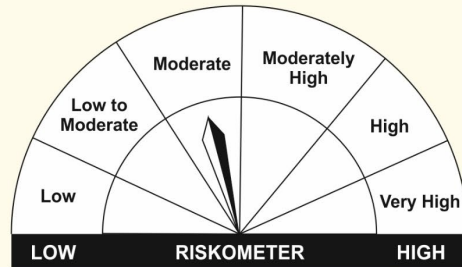
